Subject: Disbursement of K2 benefit to eligible girl students

Madam/ Sir,

It has been reported that owing to educational institutions being currently closed in the Covid-19 pandemic situation, Kanyashree beneficiaries who have passed their class XII board examinations in 2020 could not complete admission procedures at colleges. Due to this delay in admission, their K2 benefit disbursement is being held up, although they are otherwise eligible for the same.

With a view to ensure that no Kanyashree beneficiary is deprived of timely K2 benefit, it has been decided that girl students who are otherwise eligible for getting K2 benefit in Kanyashree years 2019-20 and 2020-21, may submit a self-declaration to the head of the educational institute wherefrom they passed Ucchya Madhyamik/ equivalent examination, along with duly filled up K2 up gradation form.

A model self-declaration format (in Bengali and English) is enclosed, which is to be used for the purpose.

The educational institution where such students were enrolled previously must be directed to generate and provide the K2 upgradation form to the eligible beneficiary, to collect such filled up forms, together with the self-declarations, from the said eligible K2 beneficiaries and duly upload them.

DPMUs will closely monitor the entire exercise.

NIC is being requested to provide necessary technical support for the exercise.

This process should be taken up on urgent basis so that no eligible K2 beneficiary is deprived of Kanyashree benefit.
