By virtue of its existence as a government-aided college of higher education, the code of conduct of Raniganj Girls' College is basically governed by the rules and regulations formulated by the Department of Higher Education, Government of West Bengal. Again, by virtue of its affiliation, the code of conduct of this institution is also governed to a considerable extent by the statutory provisions of Kazi Nazrul University. Further, because of the institution's recognition by University Grants Commission (UGC) under sections 2(f) and 12(B), the code of conduct is also governed by the rules and regulations as formulated by UGC from time to time.

A Short Handbook on the Code of Ethical Conduct is a humble initiative to outline the code of conduct of the different stakeholders prepared out of ethical consideration and moral suasion.



Code of Conduct for the Head of the Institution

The Principal as the Head of the Institution

- Being at the helm of the administrative hierarchy directs and co-ordinates all types of the college activities namely academic, financial or administrative and maintains the competence and efficacy of the entire governance process of the college.
- Being the ex-officio Secretary of the Governing Body of the College, she is the liaison between the organisation and the management.
- Ensures that the acts, statutes, ordinances, rules and regulations and different notifications and orders issued from time to time by the affiliating Kazi Nazrul University, Department of Higher Education, Government of West Bengal, University Grants Commission and other regulatory authorities are abided by.
- Supervises the planning and execution of developmental goals for academic excellence as well as administrative governance of the college in conformity with the mission and vision of the college in consultation with the members of different statutory and non-statutory bodies constituted for such purposes.
- Maintains discipline and decorum in the college.

- As the Drawing and Disbursing Officer of the institution shoulders the ultimate responsibility for financial management and financial accountability.

- Monitors the smooth conduct of curricular, co-curricular and extra-curricular activities of the college.
- Plays a supportive role for the welfare of the students, stakeholders at large and the neighbouring community of the locality

- To interact with the peers as well as the members of the non-teaching fraternity with respect and collaborate with them in discharging activities of any nature be it academic or administrative undertaken in the interest of the welfare and development of the institution

- To be committed in the holistic development of the student's personality in conformity with the mission and vision of the college
- To responsibly interact with parents and other stakeholders of the institution in a positive manner
- To be well conversant in the latest developments related to their field of thinking
- To refrain from acts of plagiarism and uphold the virtue of professional ethics
- To mentor the students and their parents on socio-economic issues and encourage the learners to become self-reliant

Code of Conduct for the Students of the Institution

- Every student must possess an Identity Card with his/her photo affixed on it duly attested by the college authority and produce the same whenever and wherever deemed necessary by the college authorities.
- Students are expected to be punctual to their classes while maintaining the discipline and decorum of the college.
- Students are expected to be aware of and respect the institutional hierarchy
- Students are expected to maintain the academic culture of the college and engage in co-curricular and extra-curricular activities

- Students shall not involve in any form of ragging inside or outside the college campus.
- Students shall exhibit a tolerant attitude and not involve in any kind of discrimination
- Students shall interact with and treat their peers and other stakeholders of the college with respect and dignity.

- Students will not take recourse to any kind of unfair means while appearing for any type of college or university examination.
